**A RESOLUTION DECLARING SUFFICIENCY OF PETITION AND SETTING A
PUBLIC HEARING ON A VACATION COMMENCED BY A PETITION OF A
MAJORITY OF ABUTTING LANDOWNERS**

WHEREAS, a petition signed by the majority of property owners abutting Northern Pacific Road and Blacksmith Circle in the City of Brainerd and was received by the City Clerk on the 23rd day of August 2019; and

WHEREAS, the petition requested that the City Council pursuant to Minnesota Statute §412.851 vacate Northern Pacific Road and Blacksmith Circle legally described as:

That portion of Northern Pacific Road and Blacksmith Circle lying easterly of the easterly right-of-way line of 13th Street SE (County State Aid Highway 45) in the Northern Pacific Center Addition to the City of Brainerd.

WHEREAS, the City Clerk has reviewed and examined the signatures on said petition and determined that such signatures constitute a majority of the landowners abutting upon the portion of each street to be vacated; and
