#### **Presentations**

The Chair welcomed Ms. Amy Wyant and Mr. Tom Gonzalez, project coordinators for Bridges of Hope who presented updates of the Self-Healing Communities project. Ms. Wyant shared the greatest needs identified and messages of hope and education. Bridges of Hope partners with Crow Wing County Community Services and recently received data on the chemical related child protection reports. She stated the focus has been on the out of home placement data points which are high in Crow Wing County. Ms. Wyant reviewed some of the specific areas that they are working on in building healthy families. Mr. Gonzalez presented statistics from the origination of the Self-Healing Communities model based in the state of Washington that focus on Adverse Childhood Experiences (ACEs). The Chair thanked them for the presentation.

The Chair welcomed Mr. Tyler Glynn, economic development officer for Brainerd Lakes Area Economic Development Corporation (BLAEDC) who stated he will be presenting updates every other month to the Council in conjunction with the Economic Development Authority (EDA) meetings. He is working with City Administrator Torstenson on improving communication with the City regarding updates of the various projects. The BLAEDC Annual Meeting is taking place on February 25, 2019 at Arrowhead Lodge at 11:30 a.m. with former Duluth Mayor Don Ness as the featured speaker. He indicated that there will be other presentations from individuals throughout Crow Wing County regarding different projects and invited the Council to attend. He reviewed the functions of BLAEDC and summarized what BLAEDC does for the community. Mr. Glynn also briefly explained Opportunity Zones, the potential financial impact they have and the BLAEDC Annual Financial Report. Questions were answered and the Chair thanked him for the presentation.

Finance Director Hillman stated the Coalition of Greater Minnesota Cities sent a message that Governor Walz has proposed LGA funding return to the 2002 levels. They are requesting the City send emails of support to the Governor which will be done.

Mayor Menk thanked Community Development Director Chanski for leading the planning retreat and the great ideas that have come out of it. He also thanked City Engineer Sandy and the Streets Department for the advanced notices on snow removal throughout the City.
