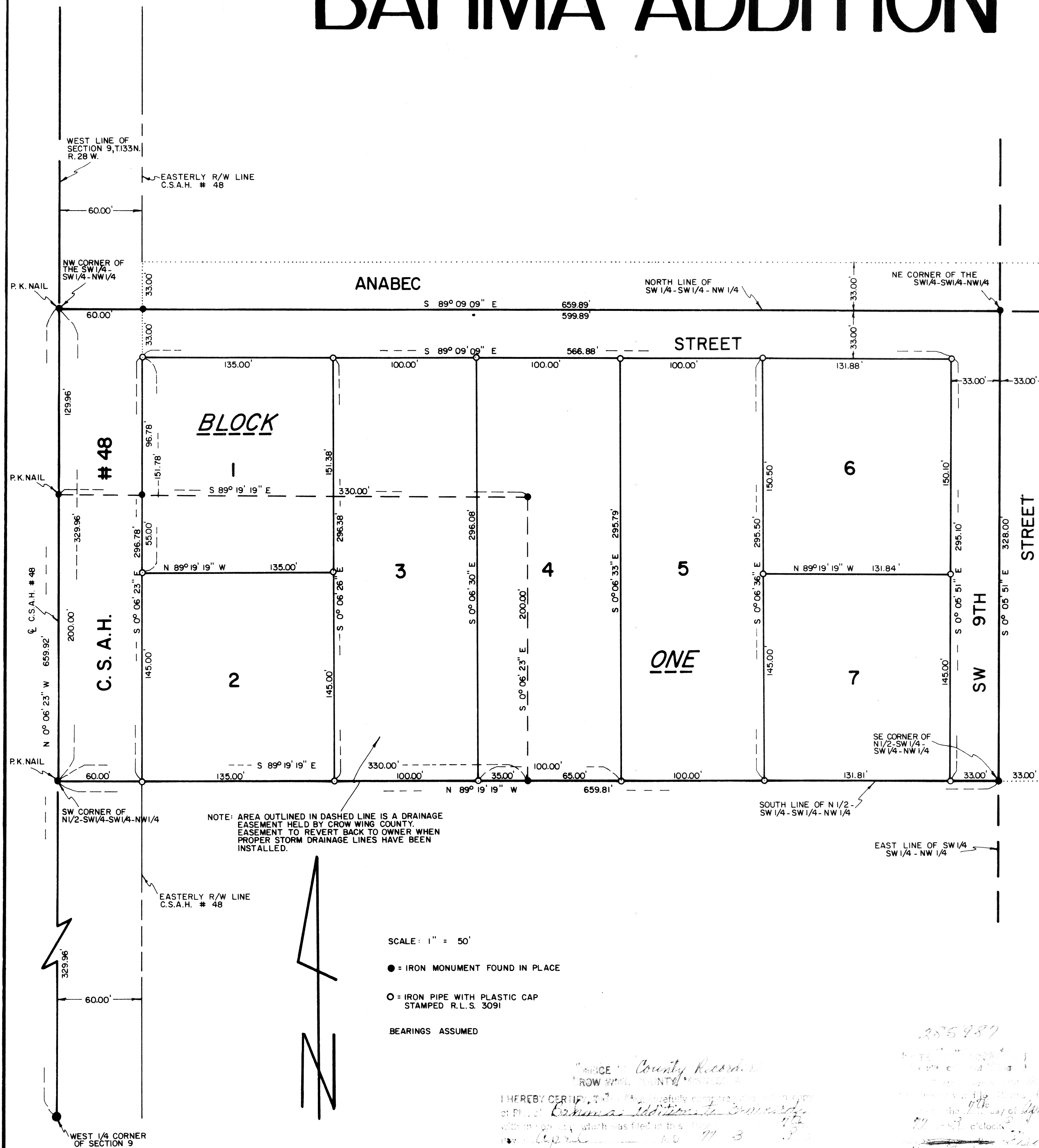


BAHMA ADDITION TO BRAINERD
