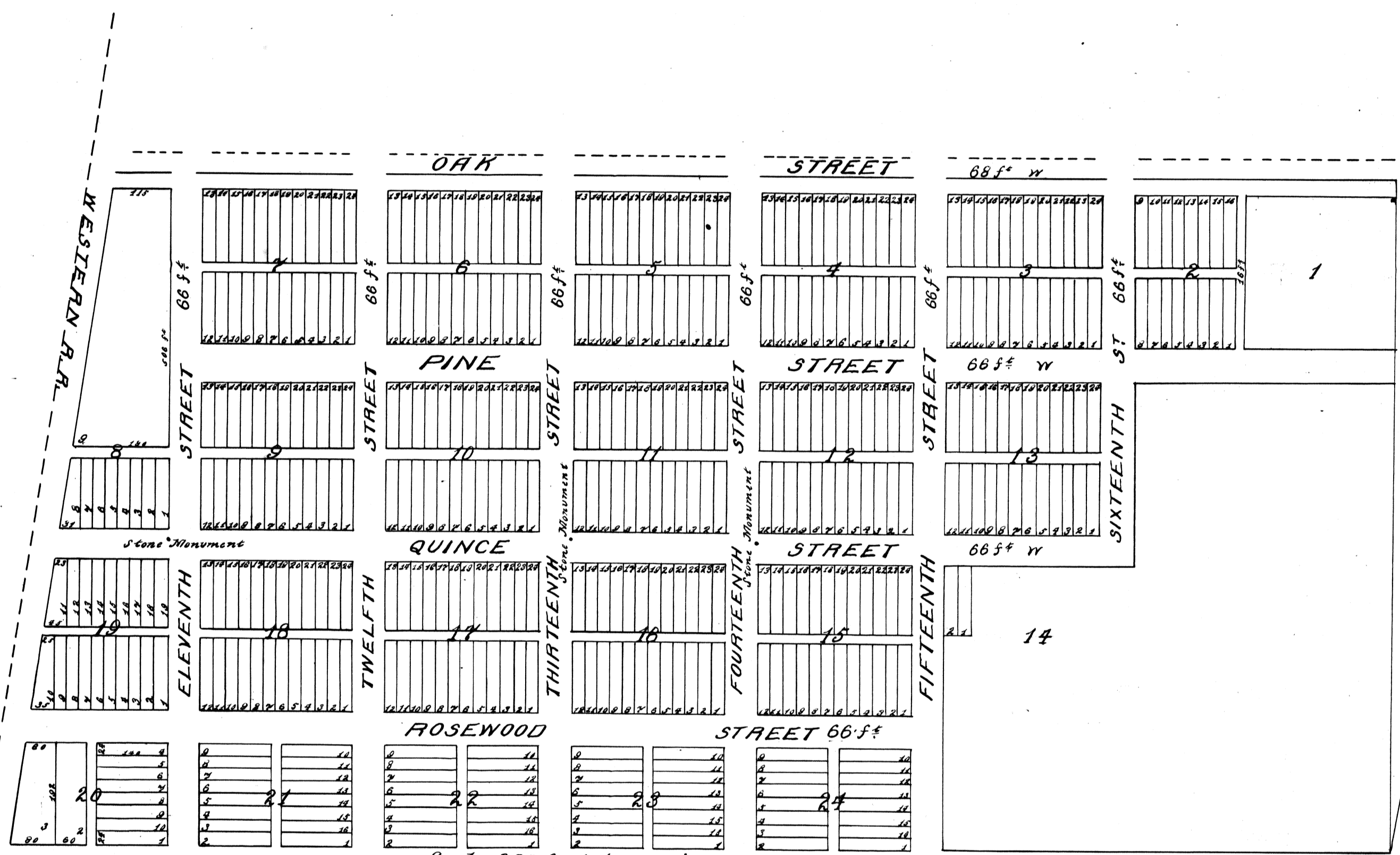


SECOND ADDITION

The second addition to the Town of Brainerd, Crow Wing Co., Minnesota is located upon the NW 1/4 of SW 1/4 Sec 30, Township 45 N., Range 30 W. 4th P.M., and all that part of the NE 1/4 of SE 1/4 Sec 20 Town 45 Range 31 W. 4th P.M. lying East of the Right of way of the Western R.R. Streets are laid out sixty six feet wide and run North and South, East and West. Alleys are 20 feet wide. Full blocks are 300 feet square, fractional blocks are marked on plat. Lots are twenty five (25) feet by one hundred forty (140) feet. Blocks 21, 22, 23 & 24 are 300 by 192 feet, lots 24 x 140 feet. Fractional lots as shown on plat. Stone monuments are placed on West line of Eleventh St. and Ten feet south of North line of Quince St. on East line of 13th St. and ten feet south of North line of Quince St. on East line of 14th St. and ten feet south of North line of Quince St.
