

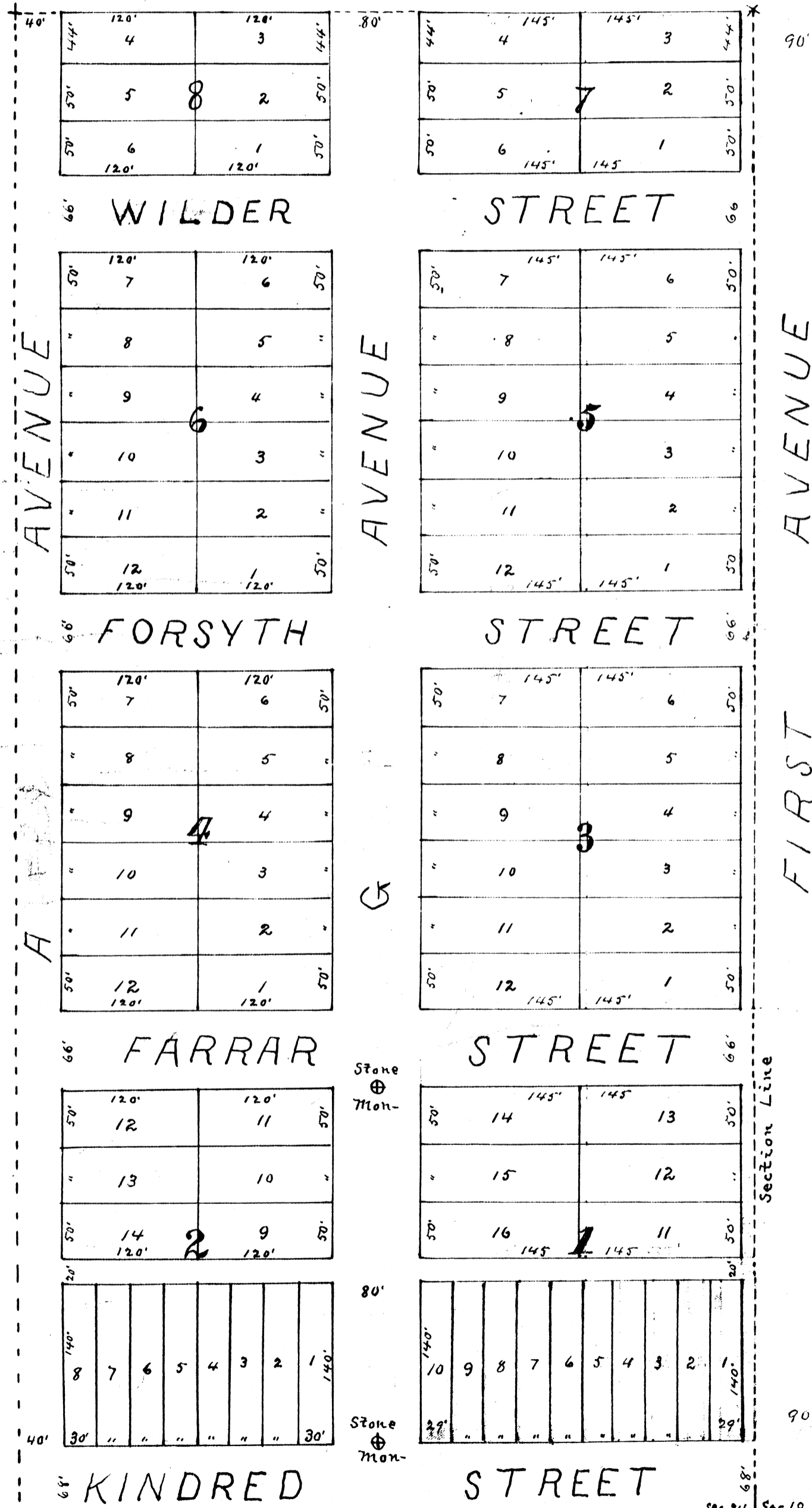
FAIRVIEW

The survey commences at the South east corner of Section 24, of said Township and Range, thence North 1320 feet; thence west 660 feet; thence South 1320 feet; thence east 660 feet; to point of beginning. The Streets are 66 feet wide, running East and West, except Kindred Street, which is 68 feet wide. Avenue is 80 feet wide, and A Avenue is 40 feet wide. The Alley in Blocks 1 & 2 is 20 feet wide. The size of all Lots is designated on the Plat. Stone Monuments marked thus \odot on the Plat - are set in the center of Willis Avenue, and on the South line of Farrar Street; and on the north line of Kindred Street.
