

L. P. White's Addition to the City of Brainerd is situated in Lot 3, Section No 24, Township No 45, North, Range No 31, West, of the 4th Principal Meridian, Crow Wing County Minnesota, and contains one and one seventh (1 1/7) acres. The survey begins at a point on the north side of Bluff Avenue in the City of Brainerd, seventy two feet and six inches south 70° and 30' west of where the east line of Lot 3, Section 24, T 45, R 31, intersects the same, thence North 120 feet, thence N 21° W 87 feet, thence South 199' 8" thence East 250 feet to point of beginning. The dimensions of the Block and Lots, are as shown on the annexed diagram. A Stone Monument is set at the southwest corner of lot 10, as shown in the diagram.

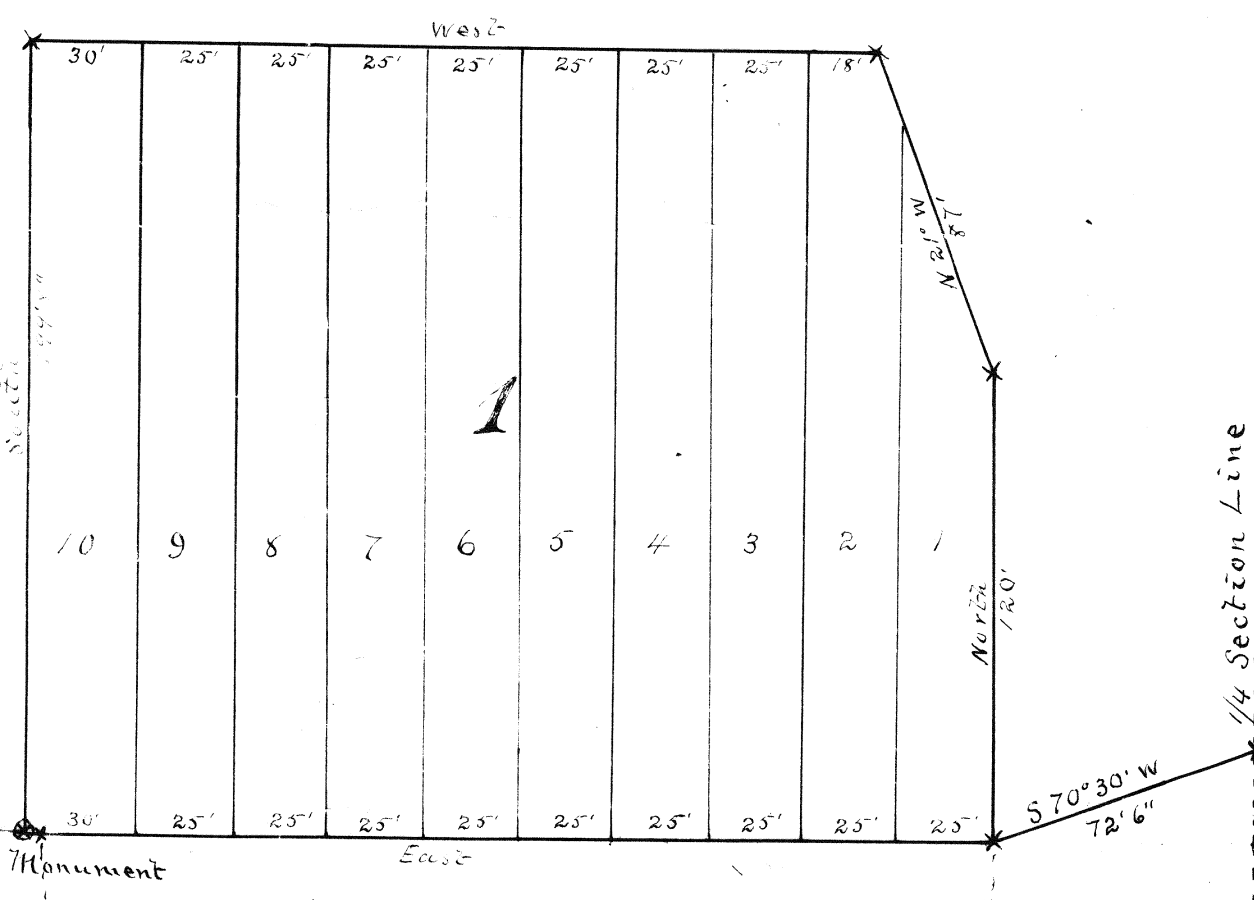
