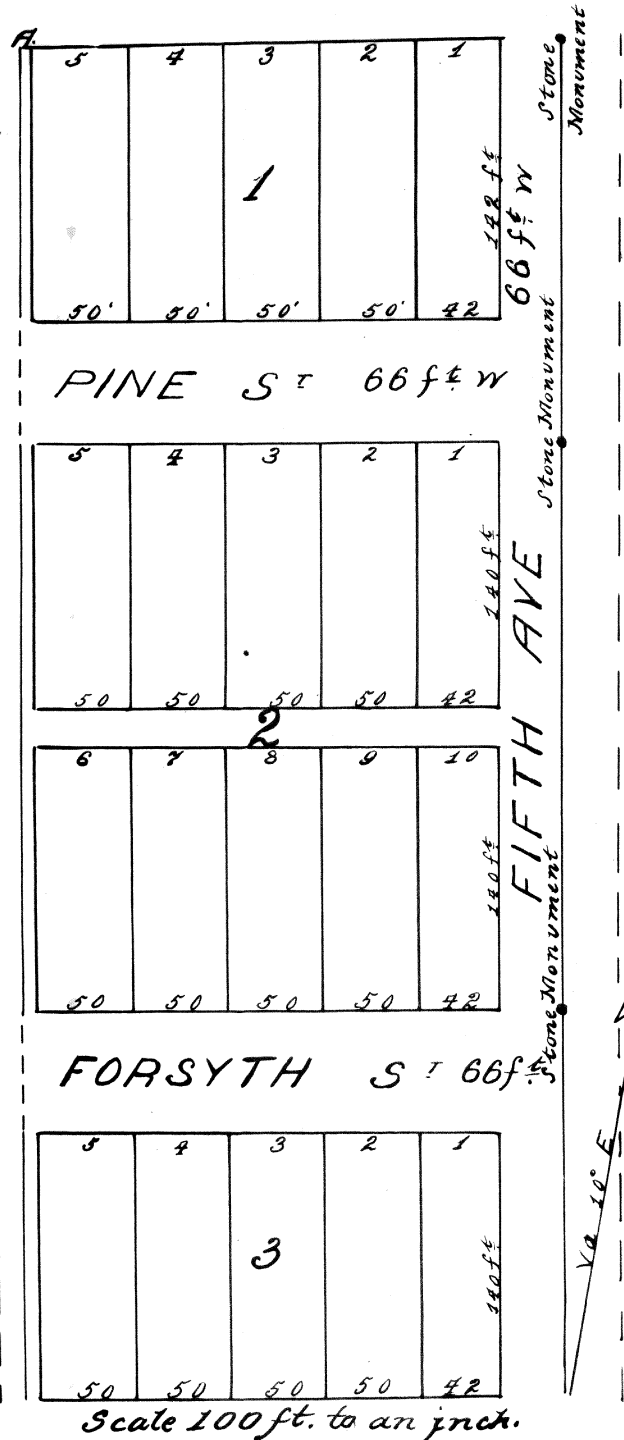


—SCHMELZ'S ADDITION—

Schmelz's addition to East Brainerd, Crow Wing County, Minn. is located on lot 3, of the SW 1/4 of Section 19, Township 45 N. Range 30 W. 4th P.M. and is bounded as follows: commencing at the Point & being the NW corner of the Plat and Lot - I run East 380 feet, thence South through center of the street 614 feet, thence West 380 feet to west line of lot, thence North 614 feet to place of beginning. Stone monuments have been placed and marked thus X in the center of 5th Avenue and South line of Pine Street, in the center of Pine St. and North line of Forsyth Street - and the center of 5th Avenue and the North line of Block 1.
