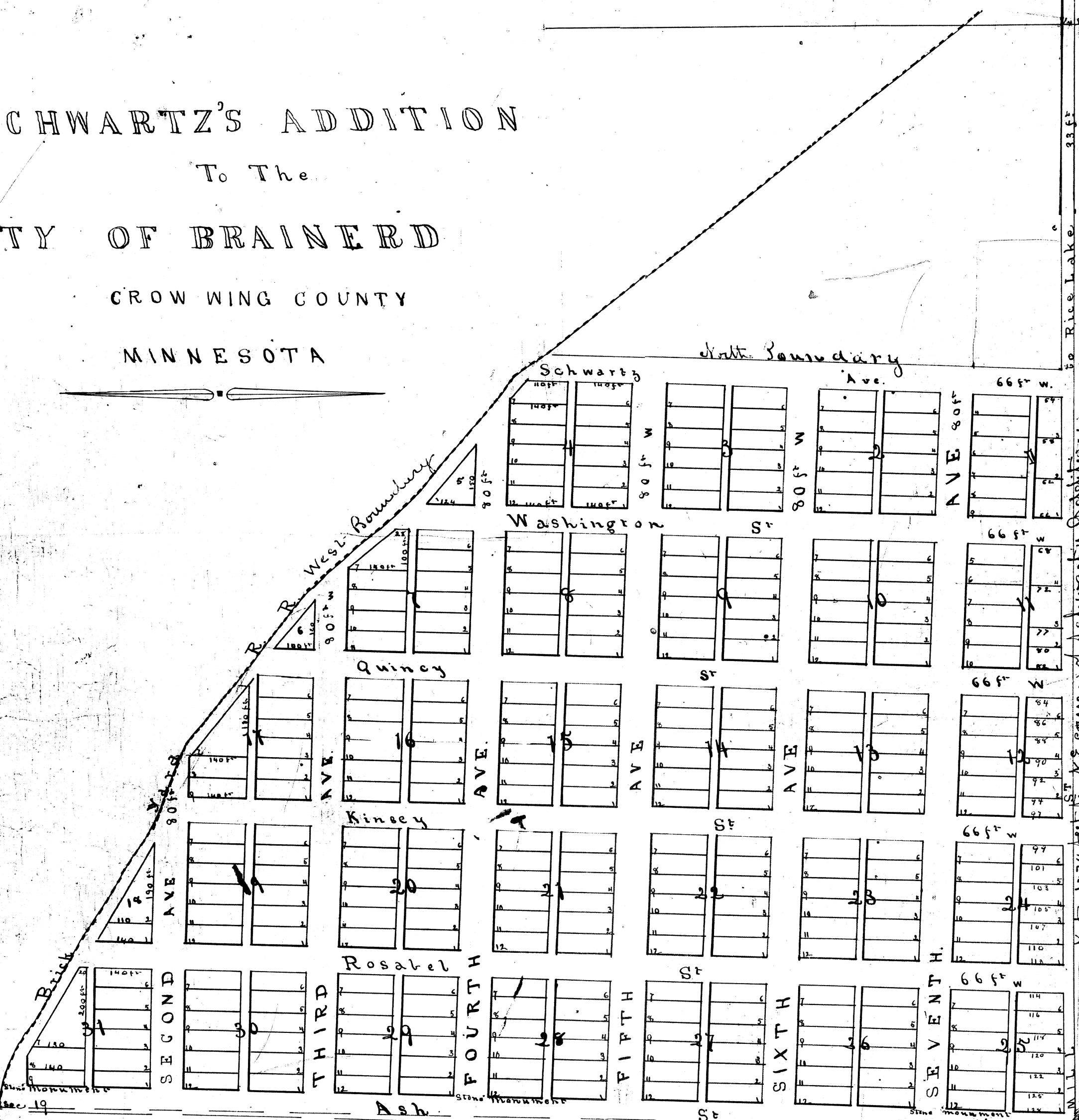


SCHWARTZ'S ADDITION

Schwartz's Brick Yard



Schwartz's Addition to the City of Brainerd, in Crow Wing County Minnesota is located upon the South 1/4 and NE 1/4 of Sec 14 345 R. 30.
5 blocks run North-South and are 50 feet wide except Mill Street which is 33 feet wide. Streets running East and West are 66 feet wide, alleys are 30 feet wide.
Full blocks are 300 feet square. Fractional blocks as marked on plat.
Lots are 50 by 140 feet, except where otherwise shown on plat.
Stone monuments have been placed on the back side of Ash St 5 feet West of the SW corner of Block 25 in Section 14, on the North side of Ash St 5 feet West of the SW corner of Block 25 in 4th Ave, on the North side of Ash St 5 feet West of the SW corner of Block 31 on First Ave. No other kind on plat.
