SUMMARY OF ISSUE:

Staff is requesting approval of a contractor quote for tree and brush removal from Kiwanis Park.

ALTERNATIVE, OPTIONS, EFFECTS ON OTHERS/COMMENTS:

The City Council allocated \$75,000 in ARPA funds for tree and brush clearing at Kiwanis Park adjacent to Boom Lake and the Mississippi River. Staff met on-site with two contractors to discuss scope of the project and to request a quote for services. Generally, the scope includes the following: dead, damaged, or diseased tree removal (no grubbing) and removal of underbrush and invasive species with brush hog or similar equipment. Both contractors provided quotes as included in the packet.

1. Tom's Backhoe = \$15,900
2. DeChantal Excavating = \$23,340

Due to the limitations with the northern long-eared bat, it would be required that the tree removal be completed prior to March 31st. This requirement was also expressed to both contractors during the scoping meeting.

RECOMMENDED ACTION/MOTION:

Approve the quote from Tom's Backhoe in the amount of \$15,900.
